

Studies on Sign Language Benefits for Children with Cochlear Implants

Research demonstrating that early access to sign language in the birth-to-three years supports — rather than hinders — language, cognitive, and developmental outcomes for deaf and hard of hearing children, including those who use cochlear implants.
